TO THE TRAFFIC VIOLATOR:

You have the right to admit, deny, or plead nolo contendere to a traffic violation. Nolo contendere means that you consent to the entry of judgment without admitting you committed the violation. If you deny you must appear in Court on the date the officer indicates on your ticket.

If you admit the violation, you may pay the fine by mail **IF** the charge on the ticket is listed below. If paying by mail, you must send a **MONEY ORDER OR CASHIER'S CHECK** made payable to: Clerk, Jasper Circuit Court, and mail it to the above address. **WE WILL NOT ACCEPT A PERSONAL OR COMPANY CHECK.** Enclose a self-addressed stamped envelope in which we can return a clerk's receipt.
