Pleading Liable By Mail: If you wish to plead Liable to your citation, you may pay the citation without appearing in court. To plead Liable, sign the “APPEARANCE, ADMISSION OF VIOLATION AND WAIVER” form at the bottom of the backside of the citation and place it in an envelope with a Money Order. The amount required to pay the citation you are charged with, is set forth below. The court is not allowed to accept Personal Checks. Money Orders must be made payable to the “DeMotte Town Court” and can be paid at the DeMotte Town Hall, 112 Carnation Street SE, or it can be mailed, along with the signed citation to:

Online or Phone Payment: Citations may also be paid on the Internet at: www.govpaynow.com or by calling 888-604-7888. Visa Discover, Mastercard and American Express are accepted. Enter pay location code (PLC): 6332 when paying online. You can contact the Judge by email at demottejudge@comcast.net or call 219-987-5138 for assistance. You may also plead Liable and pay the citation in person at the Judge’s Office at the DeMotte Town Hall, 112 Carnation Street SE. Please call 219-987-5138 for the Judge’s office hours.

If you wish to contest the citation, you are required to enter a plea of Not Liable and forward your notice thereof to the Judge’s office at the above address, where upon the court will assign the violation a trial date and will notify you by return mail. If you fail to notify the court by mail of your Not Liable plea, you will be required to appear a second time for trial. If you fail to exercise any of the above options, you must appear in court on the date and time specified at the bottom of the citation.
